**Open:** Three 1:30 minute periods, choice 2<sup>nd</sup> & 3<sup>rd</sup> periods with restarts in referees or neutral position as needed. Consi 1 min periods.

Double elimination or round-robin format. Sudden victory OT 1:00 periods until first takedown scored. 15-point technical Fall, 3 point takedown. Age and weight challenges will only be heard before a match is wrestled.
