Entry Fee: \$30.00 per wrestler

Eligibility: Age as of March 7, 2026 (Bring Birth Certificate in case of challenge)

Rules: Round robin style. Division 1-2 will be two 1:30 minute periods. Division 3-4 will be three 1:30 minute periods. All periods start on feet, out of bounds calls or lack of activity will start on feet, sudden death in OT, 12 point tech fall. **Referee's decisions are final.**
